

PCCC Temporary Grading for Students (Spring 2020 only)

PASS CREDIT/NO CREDIT GRADE

The Pass Credit (PC)/No Credit (NC) grade will apply to all courses. Students in college level courses may request a letter grade (in lieu of a Pass Credit (PC), in writing to their course instructors no later than **May 26, 2020**. These grades will apply to all courses, **EXCEPT** for pre-requisite courses for and courses in the Nurse Education, Radiography, Occupational Therapy Assistant, Health Information Management and Medical Assistant programs.

PASS CREDIT (PC)	<ul style="list-style-type: none"> • A Pass Credit (PC) grade will be awarded to all courses in lieu of an A, A-, B+, B, B-, C+, C, or D grades. • A Pass Credit (PC) grade in pre/co-requisite course(s) is acceptable for students to progress to the next course in sequence, except for pre-requisite courses for and courses in the Nurse Education, Radiography, Occupational Therapy Assistant, Health Information Management and Medical Assistant programs. • Credits are awarded • GPA is not impacted- it will not have a positive or negative impact on your GPA • In most situations, there will be no impact on your Satisfactory Academic Progress (SAP) needed to maintain financial aid. If you are on SAP Probation, contact Financial Aid at FA@pccc.edu. • Most of NJ Colleges and Universities have agreed to accept the Pass Credit (PC) grade for transfer with no penalty for the student, however, the transfer institution has the discretion to accept or reject this grade in the transfer process.

Important Things You Need to Understand about the Pass Credit (PC) Grade

- Students in **college level courses** may request a letter grade (in lieu of a Pass Credit (PC), in writing to their course instructors no later than **May 26, 2020**. The student's decision ***cannot*** be changed once submitted. Forms to request the letter grade will be on the College website starting Monday, April 20, 2020.
- Students in DE or ELS courses will only receive a Pass Credit (PC)/No Credit (NC) Grade.
- A Pass Credit (PC) or letter grade shall only be awarded if you achieved the outcomes of the course.
- The Pass Credit (PC) **grade does not apply** to pre-requisite courses for and courses in the Nurse Education, Radiography, Occupational Therapy Assistant, Health Information Management and Medical Assistant programs.
- If you wish to appeal any grade, you must appeal the faculty's decision through the College's Academic Appeals Process.
- The Pass Credit/No Credit (PC/NC) grade recorded on the student's transcript will include a notation that the Spring Semester 2020 is the COVID-19 semester.

GRADE	DESCRIPTIONS
NO CREDIT (NC)	<ul style="list-style-type: none"> • No credit awarded • GPA is not impacted-it will not have a positive or negative impact on GPAs. A notation will be made on your transcript that this occurred during Covid-19 • A No Credit (NC) grade in pre/co-requisite course(s) will not allow a student to progress to the next course in that sequence. You will need to retake and successfully complete the course.

Important Things You Need to Understand about the No Credit (NC) Grade

- A No Credit (NC) grade is not accepted in the transfer process. Students will need to retake and successfully complete the course to get full credit.
- In most situations, there will be no impact on your Satisfactory Academic Progress (SAP) needed to maintain financial aid. If you are on SAP Probation, contact Financial Aid at FA@pccc.edu.
- If you wish to appeal any grade, you must appeal the faculty's decision through the College's Academic Appeals Process.

- The Pass Credit/No Credit (PC/NC) grade recorded on the student’s transcript will include a notation that the Spring Semester 2020 is the COVID-19 semester.

INCOMPLETE (I) GRADE

Need More Time due to Covid-19 disruptions

If you feel that **you still need additional time** to complete the course requirements, you can **ask your instructor for an incomplete** (more time to complete the course work or final exam) **no later than May 26, 2020.**

Grade	Description
Incomplete (I)	<ul style="list-style-type: none"> • This is a temporary grade given when a student is unable to complete the course work or final exam due to extenuating circumstances. • Request for an Incomplete (I) grade needs to be communicated to your instructor no later than May 26, 2020. Forms will be available on the College’s website as of Monday, April 20, 2020. • Be sure to communicate with your instructor regarding the remaining items needed to be completed and how to achieve these goals. • Ask your instructor to communicate those remaining requirements in writing so that there is no confusion and can serve as a check list. • The deadline to finish course work is extended to the end of Spring Semester 2021.

Important Things You Need to Understand about the Incomplete Grade

- You can **ask your instructor for an incomplete** (more time to complete the course work or final exam) **no later than May 26, 2020.** Your decision ***cannot*** be changed once submitted.
- **If this is a pre-requisite or co-requisite course, you will not be able to register for the next course in the sequence** before completing this course
- **If you do not complete** your work by end of **Spring 2021**, your **“I” turns to an “F”** and you will not get credit for this course and it can impact your Financial Aid.

WITHDRAWAL GRADE

If a student is dealing with a number of life disruptions during or prior to Covid-19, the College understands that withdrawing from a course(s) is the right choice for you. The **deadline to withdraw** with faculty permission is **April 29, 2020**

Withdraw (W) <i>Dropping a course(s)</i>	<p>Process to withdraw:</p> <ul style="list-style-type: none"> • You may request a “W” by completing the Drop/Add form and send to your instructor for approval. The instructor and department chair will review and forward to the registrar’s office for formal withdrawal. Forms will be available on Monday, April 20, 2020. • Check your grades at the end of the semester for accuracy. • Schedule a meeting with your academic advisor or the Center for Student Success to discuss next steps.

Important Things You Need to Understand about the Withdrawal

- The **deadline to withdraw** with faculty permission is **April 29, 2020.** The student’s decision ***cannot*** be changed once submitted.
- No tuition/course fee refunds or credits will be posted to your account.
- W grades ***do not transfer*** to other institutions.
